Information leaflet for **patients** regarding the COVID access rules at the Wiener Privatklinik (as of 17th september 2021)

Dear patient!

Welcome to the Wiener Privatklinik!

In order to ensure your safety as well as the safety of other patients and our staff in times of the Covid pandemic, it is imperative that the following **rules and definitions** for access to the clinic are observed. Please prove **your identity** at the checkpoint by means of **an official identity document with a photograph**. We thank you for your understanding!

1. If you are already protected by a complete vaccination, this applies without exception:

- a. Vaccination certificate or vaccination card combined with an official identity document with a photograph
- b. On the day of admission, a PCR test and an antigen test are carried out in the WPK.
 - A valid PCR test (from an approved test facility) can also be brought.
- 2. If you are NOT yet protected by a complete vaccination, this applies without exception:
 - a. Vaccination certificate or vaccination card combined with an official identity document with a photograph
 - b. Access only upon presentation of a valid, negative PCR test from an approved test facility **AND** performance of an antigen test **performed directly at the WPK prior to admission**. (Result will be available in a few minutes and must be waited for);
 - c. If you cannot provide a negative PCR test at the time of admission, we offer you the option of having it performed directly at the Wiener Privatklinik in a timely manner. Important hereby: since the evaluation of the result can take more than 12 hours, we ask you to wait for the electronic transmission of the result at home.;
 - d. In the event of an **acute**, **medically indicated emergency admission**, please contact the staff of the checkpoint.

DEFINITION (what will be accepted in the Wiener Privatklinik):

 a. "complete vaccination" = all mandatory partial vaccinations (2 partial vaccinations, with Johnson & Johnson only 1 partial vaccination) + 10 days after the last partial vaccination; Vaccinations are only valid if the vaccine is officially licensed in the EU (as of 1st september 2021 those are the following companies: BionTechPfizer (Comirnaty), Moderna (COVID-19 Vaccine Moderna), Astrazeneca (Vaxzevria), Johnson & Johnson (COVID-19 Vaccine Janssen))

The international vaccination certificate or also a vaccination card, which must contain the name of the vaccinated person, or the printout from the ELGA vaccination register or the Austrian digital passport, in each case in conjunction with a photo ID, is accepted as proof of vaccination;

- **b.** Valid PCR-Test: must be issued by a certified Austrian laboratory or an official Austrian test lane and must not be older than 48 hours from the time of sample collection;
- c. Antigen-Test: must be issued by a certified Austrian laboratory or an official Austrian test lane, and must not be older than 24 hours from the time of sample collection;
 Cost antigen test when tested in the day clinic of the WPK: 25 Euro
- **d.** Gargle self-tests, self-tests, antibody tests and segregation notices are not accepted!
